# **DEFINITION OF TERMS**

#### PIRACY

- (A) Any illegal acts of Violence or Detention, or any act of Depredation, committed for private ends by the crew or the passengers of a private ship or a private aircraft, and directed: (i) on the High Seas, against another Ship or Aircraft, or against persons or property on board such ship or aircraft. (ii) against a ship, aircraft, persons or property in a place outside the jurisdiction of any State.
- (B) Any act of voluntary participation in the operation of a ship or of an aircraft with knowledge of facts making it a pirate ship or aircraft.
- (C) Any act of inciting or of intentionally facilitating an act described in subparagraph (a) or (b).

#### • ARMED ROBBERY AT SEA

Any unlawful act of Violence or Detention, or any act of Depredation or Threat other than an act of Piracy, directed against a Ship or against Persons or Property onboard such Ships, within a States jurisdiction over such offences.

- **HIJACK**: Vessels taken by attacker, no longer under the control of the master.
- FIRED UPON/ATTACK: Use of weapon by assailants at vessel or boarding with intent to take control of the vessel.
- **BOARDING**: Unauthorized boarding of a vessel by persons not part of its complement without taken control of the vessel.
- **ROBBERY**: Theft realize in territorial waters with threat or violence to crew.
- **THEFT**: Theft realize in territorial waters with no violence.

#### • ILLEGAL UNREPORTED UNREGULATED FISHING.

Illegal fishing conducted by national or foreign vessels in contravention of laws and regulations. Fishing conducted by vessels flying the flag of States that are parties to a regional fisheries management organization but operate in contravention of the conservation and management measures. Fishing in violation of national laws or international obligations. Fishing activities which have not been reported, or have been misreported. Fishing in the area of application of a regional fisheries management organization that are conducted by vessels without nationality. Fishing in areas or for fish stocks in relation to which there are no applicable conservation or management measures.

• MARITIME MIGRATION.

STOWAWAY: A person who hides on a ship, aircraft, or other vehicle 2. Someone who hides on a ship or aircraft to travel without having to pay.

• ILLICIT TRADE.

**ILLEGAL BUNKERING**: Bunkering is a term used to describe the process of filling a ship with oil (or coal). Illegal oil bunkering is a euphemism for theft.

• OTHER MARITIME INCIDENCES.

SUSPICIOUS APPROACH: All other unexplained activity in close proximity of an unknown vessel.

SIGHTING AND IRREGULAR ACTIVITY: All suspicious information with no proof of intent to board the vessel.

# **OVERVIEW**

• The general maritime safety and security situation in Maritime Zone F and the Gulf of Guinea (GoG) remained safe and secure.

No incident was recorded in Maritime Zone F.

## DETAILS OF INCIDENT

### SUSPECTED STOWAWAY INCIDENT - ACCRA, GHANA.

Information received indicates that, the Liberia flag tanker vessel QUEEN ZENOBIA was attacked about 181NM South of Accra on 07 October 2021.

According to the report, the duty engineer on his routine rounds heard bangs at steering gear room from the under ruder trunk hatches. After getting closure, he heard voices. The Master was informed, and upon his arrival at the scene noticed that there were perpetrators inside the Rudder trunk trying to perforate holes in the hatch with axes. The hatches were lock to prevent perpetrators from escaping.

The master engage full speed and heading to Lagos, Nigeria. The vessel is currently about 176nm South of Ada Foah, Ghana.

# DETAILS OF INCIDENT

Analysis of the history trail of the vessel shows that the vessel departed Lagos port on 4 October 2021. The vessel has also been observed to be loitering around the general area of the incident since 5 October 2021.

So far, the vessel has not reported of any approach or attack by pirate skiff.

It is therefore suspected that the perpetrators locked up in the rudder trunk are stowaways who boarded the vessel at the anchorage and are trapped up thereby trying to create holes in the trunk to access fresh air.

# GENERAL COMMENTS/ADVISORIES


- > The week under review was generally calm.
- The threat of piracy attacks against ships within the GoG still exists especially from the eastern waters of Ghana to Gabon.
- Coastal law enforcement agencies are encouraged to increase surveillance and patrols within the GoG to deter pirate attacks or enable quick response in case of pirates attack.
- All vessels transiting the GoG are advised to be extra vigilant, maintain sharp lookout especially at night, observe anti-piracy measures contained in the BMP 5 and report any suspicious activities to the necessary authorities.

# FORCAST FOR THE COMING WEEK

### **FORECAST FOR COMING WEEK**

- Maritime Zone F is expected to be relatively safe. However pirate attacks is likely.
- Maritime Zone E and D are expected to be relatively safe. However pirate attacks is more likely.
- Maritime Zone A and G are expected to remain relatively safe. However petty theft and robberies within ports and anchorages are likely.
- Attacks against fishing vessels in the coming days are likely.


# **NOTICES**

### **Oil Fields**

• All vessels transiting close to the oilfields are to observe the promulgated maritime safety and security zones around the oil fields.

### **West African Gas Pipeline**

- The West African Gas pipeline extends from Takoradi in Ghana to Nigeria. The pipeline since its installation has experienced periodic breakages due to fishing and anchoring activities on the pipeline.
- The position of the pipeline is shown on maritime charts.
- All vessels transiting the coastal areas between Ghana and Nigeria are to avoid anchoring and fishing within the pipeline protective zone.
