DEFINITION OF TERMS

• PIRACY

(A) Any illegal acts of Violence or Detention, or any act of Depredation, committed for private ends by the crew or the passengers of a private ship or a private aircraft, and directed: (i) on the High Seas, against another Ship or Aircraft, or against persons or property on board such ship or aircraft. (ii) against a ship, aircraft, persons or property in a place outside the jurisdiction of any State.
(B) Any act of voluntary participation in the operation of a ship or of an aircraft with knowledge of facts making it a pirate ship or aircraft.
(C) Any act of inciting or of intentionally facilitating an act described in subparagraph (a) or (b).

• ARMED ROBBERY AT SEA

Any unlawful act of Violence or Detention, or any act of Depredation or Threat other than an act of Piracy, directed against a Ship or against Persons or Property onboard such Ships, within a States jurisdiction over such offences.

- HIJACK: Vessels taken by attacker, no longer under the control of the master.
- FIRED UPON/ATTACK: Use of weapon by assailants at vessel or boarding with intent to take control of the vessel.
- **BOARDING**: Unauthorized boarding of a vessel by persons not part of its complement without taken control of the vessel.
- **ROBBERY**: Theft realize in territorial waters with threat or violence to crew.
- **THEFT**: Theft realize in territorial waters with no violence.
- ILLEGAL UNREPORTED UNREGULATED FISHING.

Illegal fishing conducted by national or foreign vessels in contravention of laws and regulations. Fishing conducted by vessels flying the flag of States that are parties to a regional fisheries management organization but operate in contravention of the conservation and management measures. Fishing in violation of national laws or international obligations. Fishing activities which have not been reported, or have been misreported. Fishing in the area of application of a regional fisheries management organization that are conducted by vessels without nationality. Fishing in areas or for fish stocks in relation to which there are no applicable conservation or management measures.

• MARITIME MIGRATION.

STOWAWAY: A person who hides on a ship, aircraft, or other vehicle 2. Someone who hides on a ship or aircraft to travel without having to pay.

• ILLICIT TRADE.

ILLEGAL BUNKERING: Bunkering is a term used to describe the process of filling a ship with oil (or coal). Illegal oil bunkering is a euphemism for theft.

• OTHER MARITIME INCIDENCES.

SUSPICIOUS APPROACH: All other unexplained activity in close proximity of an unknown vessel. **SIGHTING AND IRREGULAR ACTIVITY**: All suspicious information with no proof of intent to board the vessel.


SUSPICIOUS APPROACH – GUADALUPE, SAO TOME AND PRINCIPE

An unidentified vessel reported of a suspicious approach by a speed boat about 35nm North of Guadalupe, Sao Tome and Principe on 07 November 2021 at 1305 UTC.

According to the report, the speedboat was making speed of about 23kts when it was sighted. The vessel altered course and increased speed. The speedboat pursued the vessel for about 5nm before abandoning the pursuit.




DETAILS OF INCIDENT

KIDNAPPED – BRASS, NIGERIA

The Cameroonian flag general cargo vessel CAP SAINT GEORGES was attacked about 61nm Southwest off Brass, Nigeria at 0100 UTC on 11 November 2021.

According to the report, an unknown number of pirates boarded the vessel and abducted 5 crew. The vessel and remaining crew were reported to be safe. The report further indicated that the same vessel was involved in similar incident on 10 December 2020 where the same crew members were kidnapped.



INCREASED THREAT TO SHIPPING

The demarcated area below with following coordinates remains a high risk area to shipping with increased threat.



The general area is about 26,904 square nautical miles covering the EEZ south of the Niger Delta Region, the northern waters Sao Tome and Principe and the Joint Development Zone. The area has so far recorded about 3 incidents including MAERSK CARDIFF and LNG SOKOTO. The attack on MSC LUCIA on 25 October 2021 is about 7nm west of the demarcated area.

The area has recorded 11 offshore incidents including three kidnapping incidents. The latest incident recorded in the area is the kidnapping of 5 crew members onboard MV CAP SAINT GEORGES on 11 November 2021.

GENERAL COMMENTS/ADVISORIES

- > The week under review has recorded one kidnapping and suspicious approach each.
- The threat of piracy attacks against ships remains high within the demarcated area and beyond. The kidnapping incident occurred within this area.
- All vessels transiting the general area and beyond are therefore advised to be extra vigilant, maintain sharp lookout especially at night and report any suspicious activities to the necessary authorities.
- Coastal law enforcement agencies are encouraged to increase surveillance and patrols within the GoG to deter pirate attacks or enable quick response in case of pirates attack.


> Maritime Zone F is expected to be relatively safe. However pirate attacks is likely.

MARITIME RISK AREAS




NOTICES

Oil Fields

• All vessels transiting close to the oilfields are to observe the promulgated maritime safety and security zones around the oil fields.

West African Gas Pipeline

- The West African Gas pipeline extends from Takoradi in Ghana to Nigeria. The pipeline since its installation has experienced periodic breakages due to fishing and anchoring activities on the pipeline.
- The position of the pipeline is shown on maritime charts.
- All vessels transiting the coastal areas between Ghana and Nigeria are to avoid anchoring and fishing within the pipeline protective zone.
