

WEEKLY MARITIME SECURITY AND SAFETY REPORT NO. 47

DEFINITION OF TERMS

PIRACY

- (A) Any illegal acts of Violence or Detention, or any act of Depredation, committed for private ends by the crew or the passengers of a private ship or a private aircraft, and directed: (i) on the High Seas, against another Ship or Aircraft, or against persons or property on board such ship or aircraft. (ii) against a ship, aircraft, persons or property in a place outside the jurisdiction of any State.
- (B) Any act of voluntary participation in the operation of a ship or of an aircraft with knowledge of facts making it a pirate ship or aircraft.
- (C) Any act of inciting or of intentionally facilitating an act described in subparagraph (a) or (b).

• ARMED ROBBERY AT SEA

Any unlawful act of Violence or Detention, or any act of Depredation or Threat other than an act of Piracy, directed against a Ship or against Persons or Property onboard such Ships, within a States jurisdiction over such offences.

- **HIJACK**: Vessels taken by attacker, no longer under the control of the master.
- FIRED UPON/ATTACK: Use of weapon by assailants at vessel or boarding with intent to take control of the vessel.
- **BOARDING**: Unauthorized boarding of a vessel by persons not part of its complement without taken control of the vessel.
- ROBBERY: Theft realize in territorial waters with threat or violence to crew.
- **THEFT**: Theft realize in territorial waters with no violence.
- ILLEGAL UNREPORTED UNREGULATED FISHING.

Illegal fishing conducted by national or foreign vessels in contravention of laws and regulations. Fishing conducted by vessels flying the flag of States that are parties to a regional fisheries management organization but operate in contravention of the conservation and management measures. Fishing in violation of national laws or international obligations. Fishing activities which have not been reported, or have been misreported. Fishing in the area of application of a regional fisheries management organization that are conducted by vessels without nationality. Fishing in areas or for fish stocks in relation to which there are no applicable conservation or management measures.

MARITIME MIGRATION.

STOWAWAY: A person who hides on a ship, aircraft, or other vehicle 2. Someone who hides on a ship or aircraft to travel without having to pay.

• ILLICIT TRADE.

ILLEGAL BUNKERING: Bunkering is a term used to describe the process of filling a ship with oil (or coal). Illegal oil bunkering is a euphemism for theft.

• OTHER MARITIME INCIDENCES.

SUSPICIOUS APPROACH: All other unexplained activity in close proximity of an unknown vessel.

SIGHTING AND IRREGULAR ACTIVITY: All suspicious information with no proof of intent to board the vessel.

OVERVIEW

DETAILS OF INCIDENT

HIJACK


Information received from MDAT-GoG indicates that, communication with MT B. OCEAN(93778340) has been lost since 232300z Nov 22 at position 01°18′ 36″N – 004°39′17″W. An update was received from NN FALCONEYE indicating MT B OCEAN was observed to have changed/transmitted her AIS navigational status interchangeably from underway using engine to restricted manoeuvrability and finally to vessel not under command between 221508 – 240017 Nov 22. This may be an obvious case of an hijack incidence and the ship's crew were possibly trying communicate for help.

Further information indicates that, the vessel was involved in three different STS with MV CAP BOJADOR and AIS was turned off at position $00^{\circ}53'$ $36''N - 004^{\circ}50'48''W$ at 220004z Nov 22.

The STS lasted for two(2) days before the attack on the vessel. The fishing vessel is currently at Abidjan port.

Further updates on the incidents will be communicated in due course.


INCIDENT POSITION



Oil Fields

• All vessels transiting close to the oilfields are to observe the promulgated maritime safety and security zones around the oil fields.

West African Gas Pipeline

- The West African Gas pipeline extends from Takoradi in Ghana to Nigeria. The pipeline since its installation has experienced periodic breakages due to fishing and anchoring activities on the pipeline.
- The position of the pipeline is shown on maritime charts.
- All vessels transiting the coastal areas between Ghana and Nigeria are to avoid anchoring and fishing within the pipeline protective zone.



MARITIME NEWS OF INTEREST

Ghana and Liberia sign a Memorandum of Understanding (MOU) for cooperation in the fight against illegal, unreported and unregulated (IUU) fishing activities.

The Minister of Fisheries and Aquaculture Development, Mavis Hawa Koomson, and Liberia's Director General of the National Fisheries and Aquaculture Authority, Madam Emma Metieh Glassco have signed a Memorandum of Understanding (MoU) to combat Illegal, Unreported, and Unregulated (IUU) fishing activities. Speaking at the signing ceremony in Accra on Monday, Madam Koomson described IUU as a major challenge facing the sub-region, with farreaching environmental and socio-economic consequences.

She cited the Organization for Economic Cooperation and Development as saying that illegal fishing costs the West African sub-region USD23 billion per year and called for a united front to combat IUU.
