# DEFINITION OF TERMS

- **PIRACY**

(A) Any illegal acts of Violence or Detention, or any act of Depredation, committed for private ends by the crew or the passengers of a private ship or a private aircraft, and directed: (i) on the High Seas, against another Ship or Aircraft, or against persons or property on board such ship or aircraft. (ii) against a ship, aircraft, persons or property in a place outside the jurisdiction of any State.

(B) Any act of voluntary participation in the operation of a ship or of an aircraft with knowledge of facts making it a pirate ship or aircraft.

(C) Any act of inciting or of intentionally facilitating an act described in subparagraph (a) or (b).

- **ARMED ROBBERY AT SEA**

Any unlawful act of Violence or Detention, or any act of Depredation or Threat other than an act of Piracy, directed against a Ship or against Persons or Property onboard such Ships, within a States jurisdiction over such offences.

- **HIJACK:** Vessels taken by attacker, no longer under the control of the master.
- **FIRED UPON/ATTACK:** Use of weapon by assailants at vessel or boarding with intent to take control of the vessel.
- **BOARDING:** Unauthorized boarding of a vessel by persons not part of its complement without taken control of the vessel.
- **ROBBERY:** Theft realize in territorial waters with threat or violence to crew.
- **THEFT:** Theft realize in territorial waters with no violence.
- **ILLEGAL UNREPORTED UNREGULATED FISHING.**

Illegal fishing conducted by national or foreign vessels in contravention of laws and regulations. Fishing conducted by vessels flying the flag of States that are parties to a regional fisheries management organization but operate in contravention of the conservation and management measures. Fishing in violation of national laws or international obligations. Fishing activities which have not been reported, or have been misreported. Fishing in the area of application of a regional fisheries management organization that are conducted by vessels without nationality. Fishing in areas or for fish stocks in relation to which there are no applicable conservation or management measures.

- **MARITIME MIGRATION.**

**STOWAWAY:** A person who hides on a ship, aircraft, or other vehicle 2. Someone who hides on a ship or aircraft to travel without having to pay.

- **ILLICIT TRADE.**

**ILLEGAL BUNKERING:** Bunkering is a term used to describe the process of filling a ship with oil (or coal). Illegal oil bunkering is a euphemism for theft.

- **OTHER MARITIME INCIDENTS.**

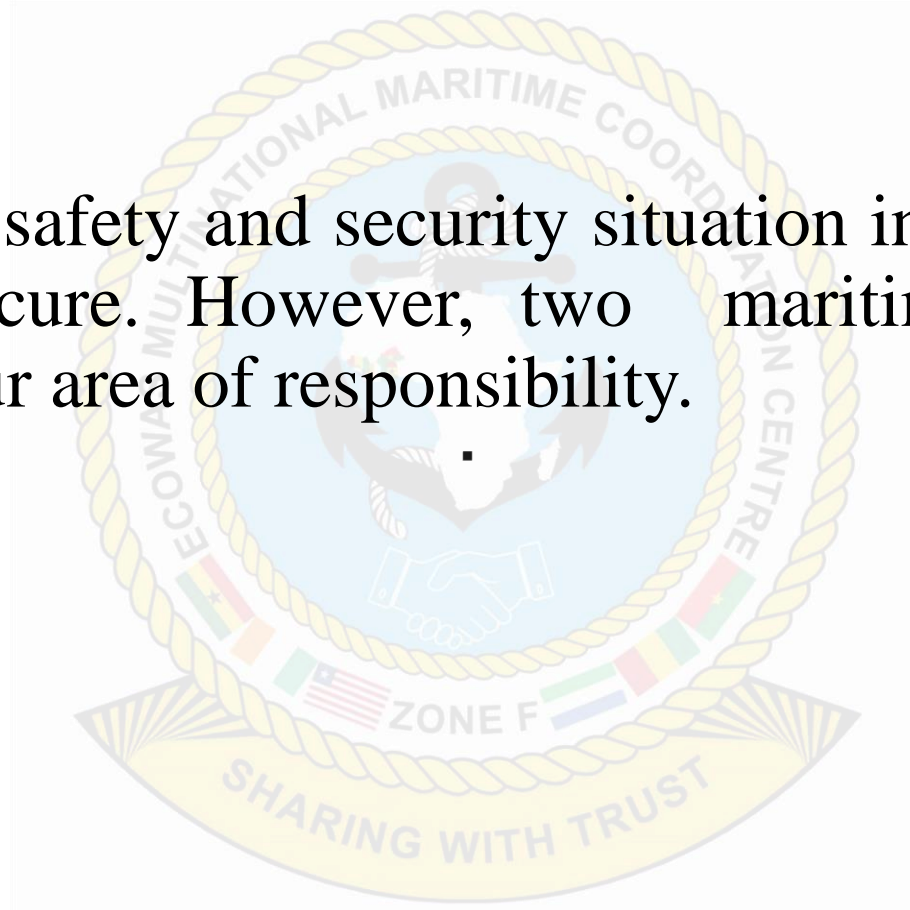
**SUSPICIOUS APPROACH:** All other unexplained activity in close proximity of an unknown vessel.

**SIGHTING AND IRREGULAR ACTIVITY:** All suspicious information with no proof of intent to board the vessel.

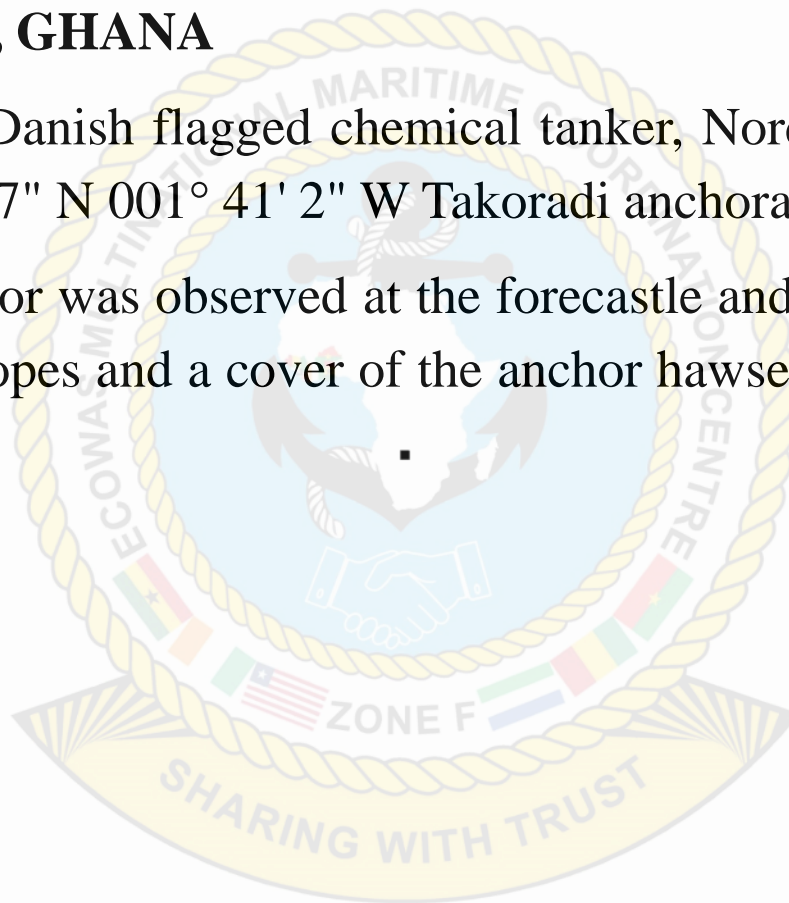

# DETAILS OF INCIDENT

## **THEFT–TAKORADI ACHORAGE, GHANA**

Information received indicates that a Danish flagged chemical tanker, Nord Stingray was boarded at 0236UTC on 2nd march 2023 at position 04° 53' 7" N 001° 41' 2" W Takoradi anchorage.

Investigations revealed that a perpetrator was observed at the forecastle and fled upon hearing the alarm. Further checks, also revealed that 2 mooring ropes and a cover of the anchor hawse pipe was stolen. Vessel and crew are safe.

# DETAILS OF INCIDENT

## **MISSING PERSONNEL- SIERRA LEONE**

Information received from the Sierra Leone MOC indicates that three(3) of their personnel left for fisheries surveillance on board White eight(8) meters fibreglass motorised boat on Saturday 25 Feb 23 from SHENGE Coastal community, Southern part of Sierra Leone waters at 07° 51'N and 013° 04'W and have since not returned which was also confirmed by the Ministry of Fisheries and Marine Resources. Search effort is ongoing by the Joint Maritime Agencies to find them but no avail.

On the 1<sup>st</sup> of march 2023, the three missing fisheries personnel were rescued at West Point in Monrovia, Liberia by local fishermen. All crew are safe and well. According to the report, they were drifted to the high seas by the waves and were not able to make it back to their original place until safely rescued in Liberia.

The Fisheries Ministry and the Sierra Leone Embassy in Liberia are working on ways to send back the personnel to Freetown.

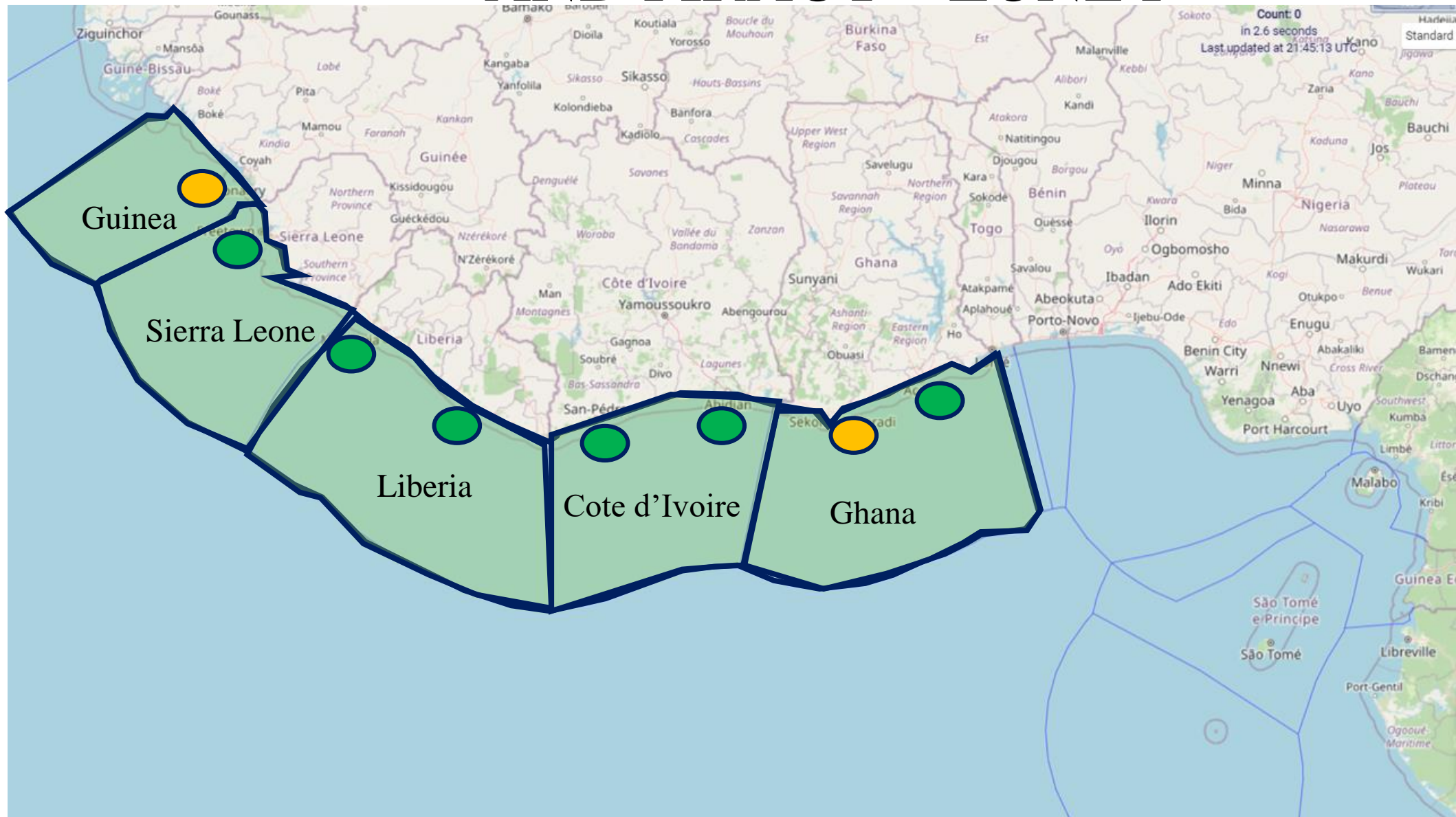

# MARITIME RISK ANALYSIS ARMED ROBBERY AND PIRACY – ZONE F



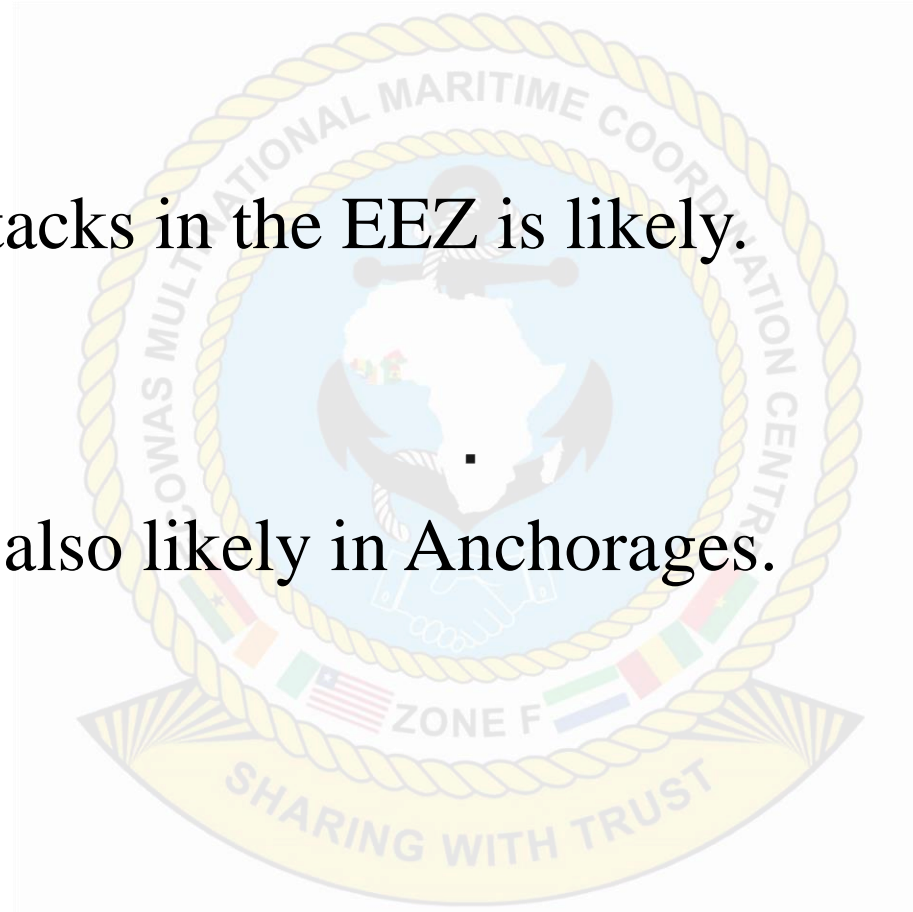

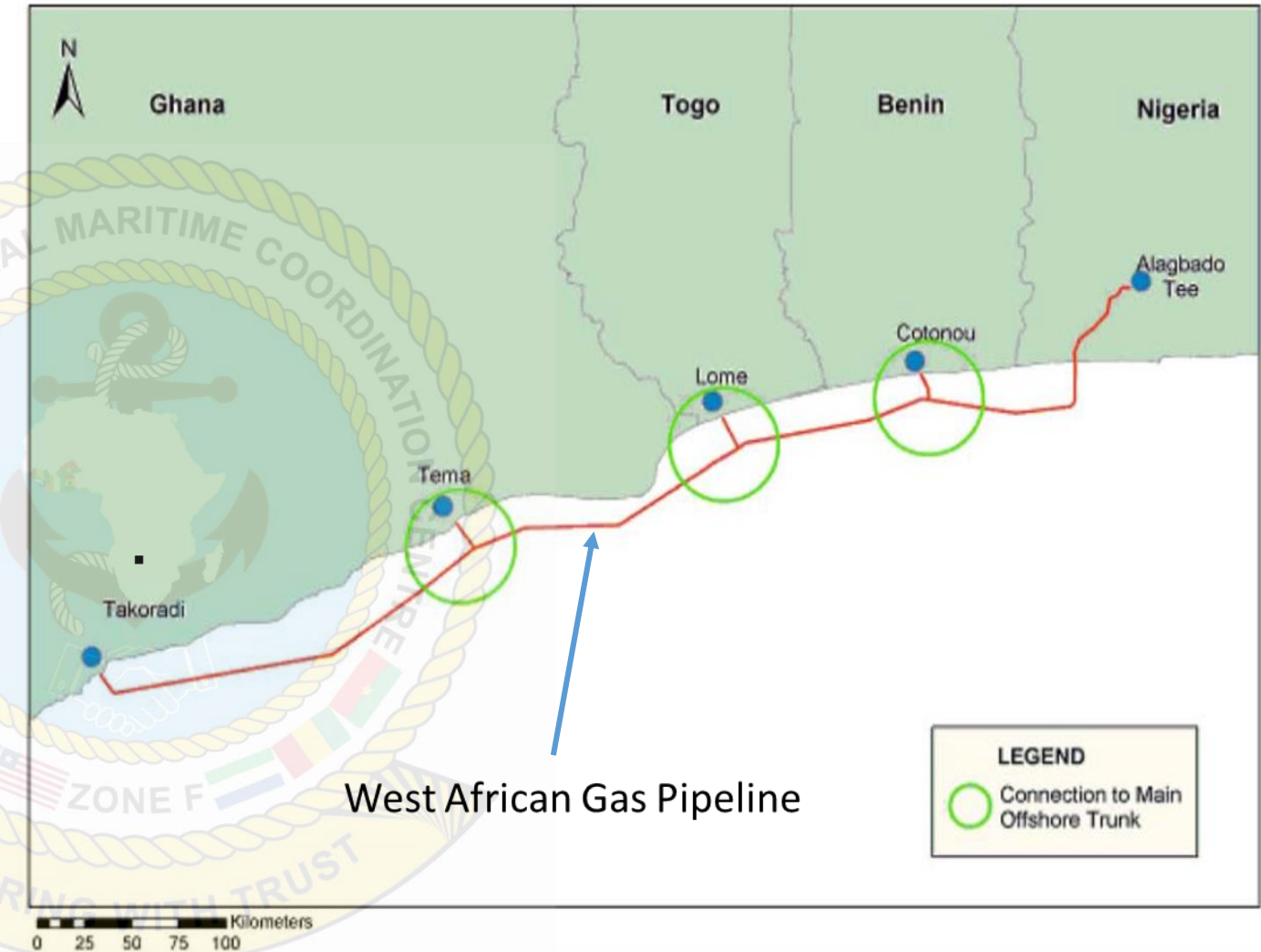
# NOTICES

## Oil Fields

- All vessels transiting close to the oilfields are to observe the promulgated maritime safety and security zones around the oil fields.

## West African Gas Pipeline

- The West African Gas pipeline extends from Takoradi in Ghana to Nigeria. The pipeline since its installation, has experienced periodic breakages due to fishing and anchoring activities on the pipeline.
- The position of the pipeline is shown on maritime charts.
- All vessels transiting the coastal areas between Ghana and Nigeria are to avoid anchoring and fishing within the pipeline protective zone.





# MARITIME NEWS OF INTEREST

## Inter-Agency Collaboration Needed To Curb Security Challenges- Navy

The Nigerian Navy says the myriad of security challenges confronting the maritime sector can be curbed with a sustained inter-agency collaboration.

Rear Adm. Sahad Akinwande, Commandant of Naval War College Nigeria, said this on Wednesday in Calabar at the Naval Warfare Course 7 inter-agency seminar 2023. The conference was hosted by the Ghana Maritime Authority in partnership with the Danish Maritime Authority and the UN's International Maritime Organization (IMO). Delegates, including many Directors-General of shipping, are gathered representing 17 maritime authorities from across the African region. With 1.3 billion people and a combined GDP of \$3.5 trillion dollars, Africa is one of the world's biggest growth markets.
