DEFINITION OF TERMS

- **PIRACY**

(A) Any illegal acts of Violence or Detention, or any act of Depredation, committed for private ends by the crew or the passengers of a private ship or a private aircraft, and directed: (i) on the High Seas, against another Ship or Aircraft, or against persons or property on board such ship or aircraft. (ii) against a ship, aircraft, persons or property in a place outside the jurisdiction of any State.

(B) Any act of voluntary participation in the operation of a ship or of an aircraft with knowledge of facts making it a pirate ship or aircraft.

(C) Any act of inciting or of intentionally facilitating an act described in subparagraph (a) or (b).

- **ARMED ROBBERY AT SEA**

Any unlawful act of Violence or Detention, or any act of Depredation or Threat other than an act of Piracy, directed against a Ship or against Persons or Property onboard such Ships, within a States jurisdiction over such offences.

- **HIJACK:** Vessels taken by attacker, no longer under the control of the master.
- **FIRED UPON/ATTACK:** Use of weapon by assailants at vessel or boarding with intent to take control of the vessel.
- **BOARDING:** Unauthorized boarding of a vessel by persons not part of its complement without taken control of the vessel.
- **ROBBERY:** Theft realize in territorial waters with threat or violence to crew.
- **THEFT:** Theft realize in territorial waters with no violence.
- **ILLEGAL UNREPORTED UNREGULATED FISHING.**

Illegal fishing conducted by national or foreign vessels in contravention of laws and regulations. Fishing conducted by vessels flying the flag of States that are parties to a regional fisheries management organization but operate in contravention of the conservation and management measures. Fishing in violation of national laws or international obligations. Fishing activities which have not been reported, or have been misreported. Fishing in the area of application of a regional fisheries management organization that are conducted by vessels without nationality. Fishing in areas or for fish stocks in relation to which there are no applicable conservation or management measures.

- **MARITIME MIGRATION.**

STOWAWAY: A person who hides on a ship, aircraft, or other vehicle 2. Someone who hides on a ship or aircraft to travel without having to pay.

- **ILLICIT TRADE.**

ILLEGAL BUNKERING: Bunkering is a term used to describe the process of filling a ship with oil (or coal). Illegal oil bunkering is a euphemism for theft.

- **OTHER MARITIME INCIDENTS.**

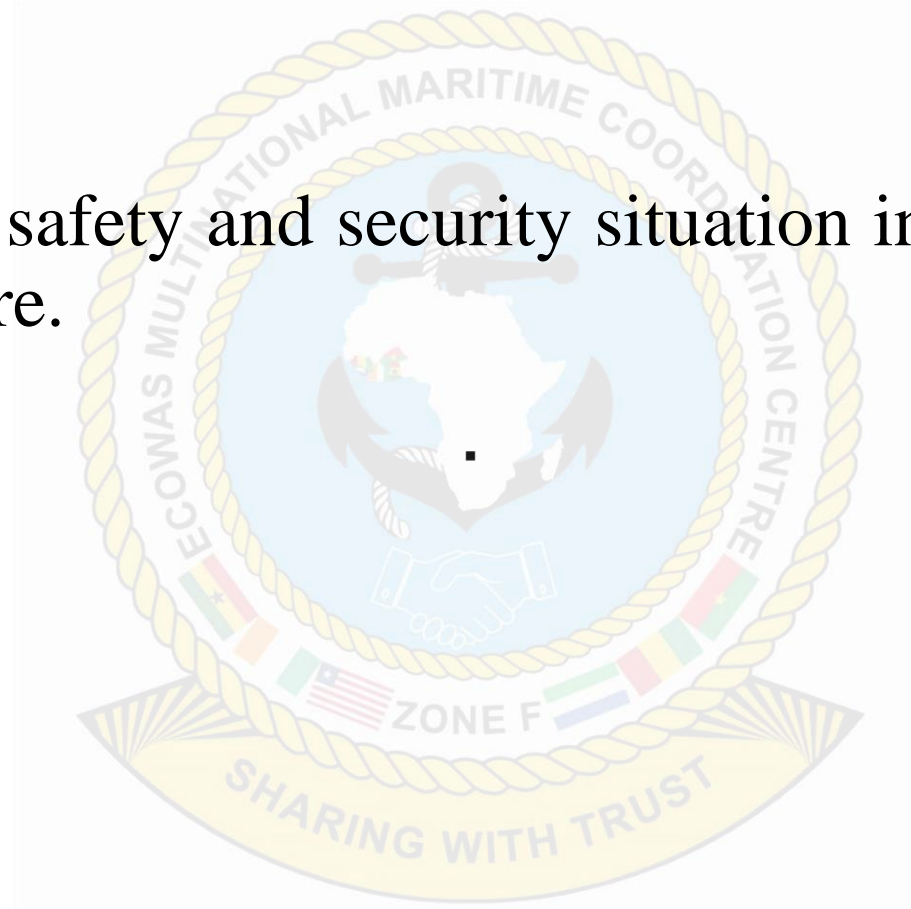
SUSPICIOUS APPROACH: All other unexplained activity in close proximity of an unknown vessel.

SIGHTING AND IRREGULAR ACTIVITY: All suspicious information with no proof of intent to board the vessel.

- The general maritime safety and security situation in Maritime Zone F remains safe and secure.



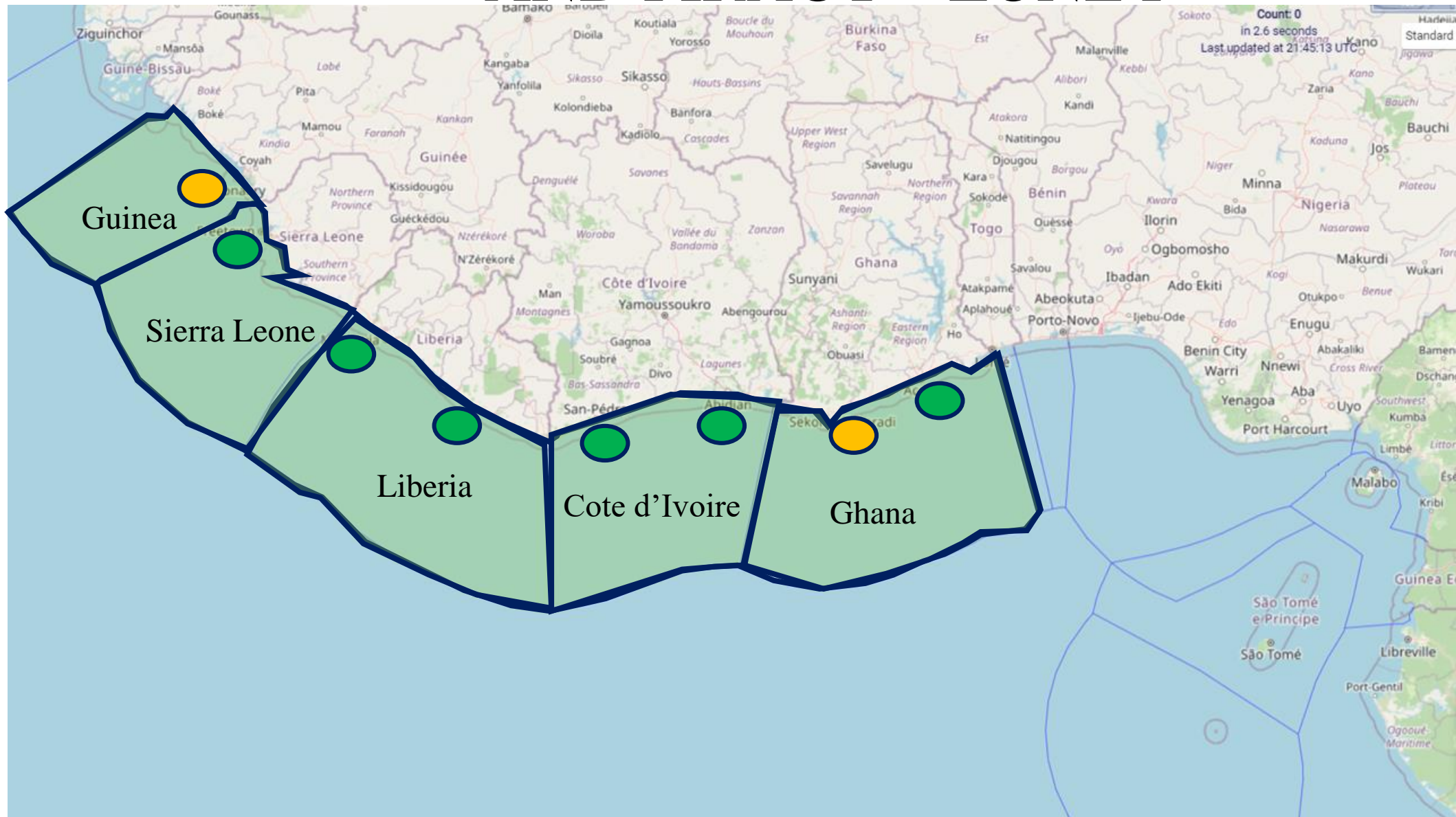

MARITIME RISK ANALYSIS ARMED ROBBERY AND PIRACY – ZONE F



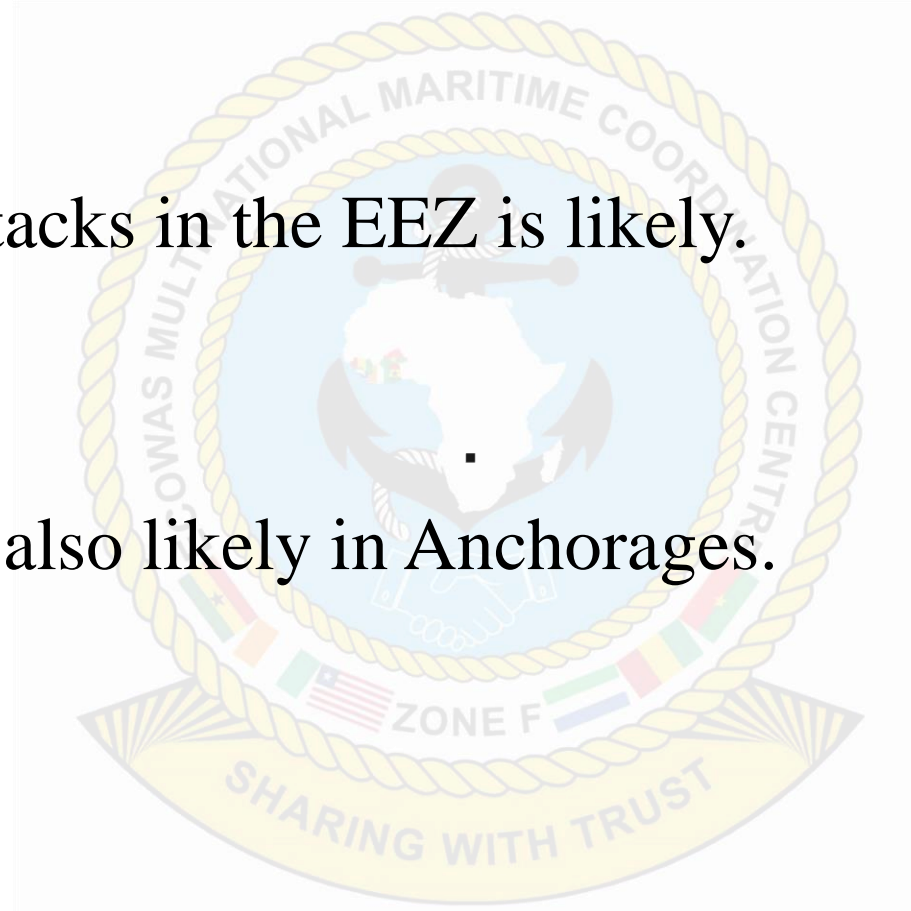

The MMCC Zone F received a delegation from the Spanish Navy on Wednesday 8th March 2023



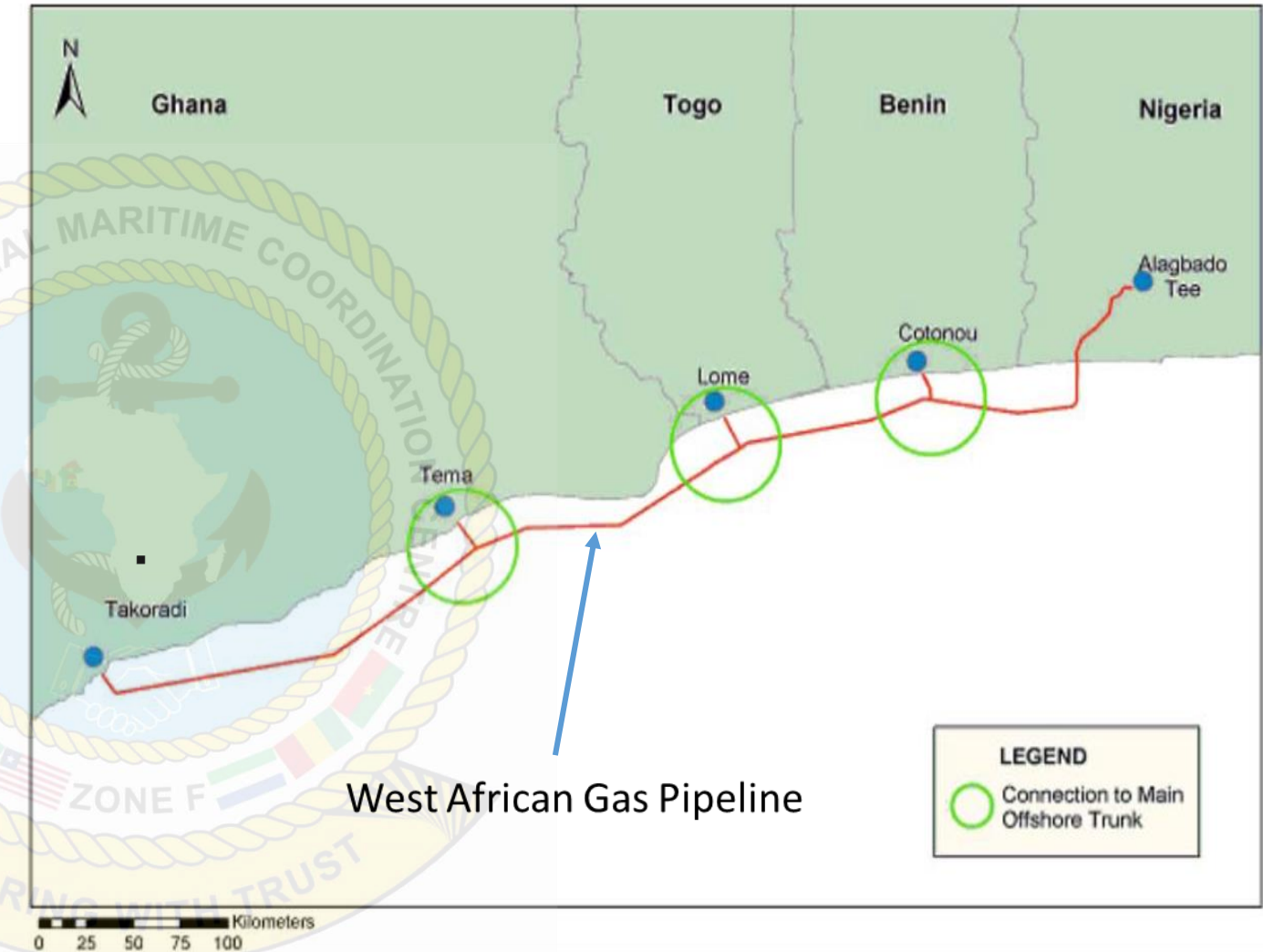
NOTICES

Oil Fields

- All vessels transiting close to the oilfields are to observe the promulgated maritime safety and security zones around the oil fields.

West African Gas Pipeline

- The West African Gas pipeline extends from Takoradi in Ghana to Nigeria. The pipeline since its installation, has experienced periodic breakages due to fishing and anchoring activities on the pipeline.
- The position of the pipeline is shown on maritime charts.
- All vessels transiting the coastal areas between Ghana and Nigeria are to avoid anchoring and fishing within the pipeline protective zone.



MARITIME NEWS OF INTEREST

Nigeria National Drug Law Enforcement Agency Intercepts 79Kilogrammes Of Hard Drugs At Tin Can Port

The Nigeria National Drug Law Enforcement Agency (NDLEA) last Friday intercepted 244 parcels of Canadian Loud weighing 79 kilograms at the Tin Port in Lagos. This was contained in a statement by the Director, Media and Advocacy, NDLEA, Mr Femi Babafemi in Abuja. Babafemi said that the illicit drugs were concealed in medium size wooden sound system speakers that were packed inside two out of four used vehicles in a container marked CRSU9258348 coming from Toronto via Montreal, Canada. “The imported vehicles used as cover for the drugs are a 2009 Jeep Wrangler and a 2009 Honda Ridgeline”.

Similarly, the NDLEA has arrested a businessman, Kingsley Celestino, at the Murtala Muhammed International Airport (MMIA) Ikeja Lagos, over 9.40 kilograms of heroin allegedly concealed in false bottoms of his two travelling bags. Babafemi said that Kingsley, a business class passenger on Qatar Airline flight, was arrested at Terminal 2 of the MMIA on Saturday on his way to India.
