DEFINITION OF TERMS

- **PIRACY**

(A) Any illegal acts of Violence or Detention, or any act of Depredation, committed for private ends by the crew or the passengers of a private ship or a private aircraft, and directed: (i) on the High Seas, against another Ship or Aircraft, or against persons or property on board such ship or aircraft. (ii) against a ship, aircraft, persons or property in a place outside the jurisdiction of any State.

(B) Any act of voluntary participation in the operation of a ship or of an aircraft with knowledge of facts making it a pirate ship or aircraft.

(C) Any act of inciting or of intentionally facilitating an act described in subparagraph (a) or (b).

- **ARMED ROBBERY AT SEA**

Any unlawful act of Violence or Detention, or any act of Depredation or Threat other than an act of Piracy, directed against a Ship or against Persons or Property onboard such Ships, within a States jurisdiction over such offences.

- **HIJACK:** Vessels taken by attacker, no longer under the control of the master.
- **FIRED UPON/ATTACK:** Use of weapon by assailants at vessel or boarding with intent to take control of the vessel.
- **BOARDING:** Unauthorized boarding of a vessel by persons not part of its complement without taken control of the vessel.
- **ROBBERY:** Theft realize in territorial waters with threat or violence to crew.
- **THEFT:** Theft realize in territorial waters with no violence.
- **ILLEGAL UNREPORTED UNREGULATED FISHING.**

Illegal fishing conducted by national or foreign vessels in contravention of laws and regulations. Fishing conducted by vessels flying the flag of States that are parties to a regional fisheries management organization but operate in contravention of the conservation and management measures. Fishing in violation of national laws or international obligations. Fishing activities which have not been reported, or have been misreported. Fishing in the area of application of a regional fisheries management organization that are conducted by vessels without nationality. Fishing in areas or for fish stocks in relation to which there are no applicable conservation or management measures.

- **MARITIME MIGRATION.**

STOWAWAY: A person who hides on a ship, aircraft, or other vehicle 2. Someone who hides on a ship or aircraft to travel without having to pay.

- **ILLICIT TRADE.**

ILLEGAL BUNKERING: Bunkering is a term used to describe the process of filling a ship with oil (or coal). Illegal oil bunkering is a euphemism for theft.

- **OTHER MARITIME INCIDENTS.**

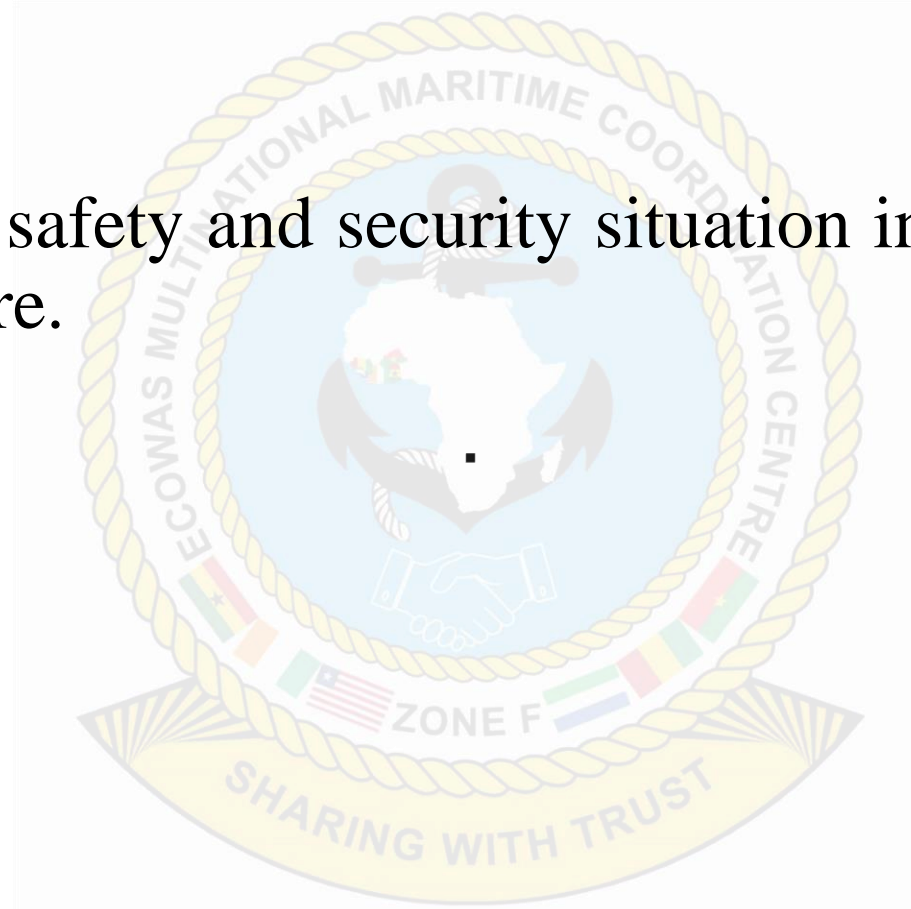
SUSPICIOUS APPROACH: All other unexplained activity in close proximity of an unknown vessel.

SIGHTING AND IRREGULAR ACTIVITY: All suspicious information with no proof of intent to board the vessel.

- The general maritime safety and security situation in Maritime Zone F remains safe and secure.



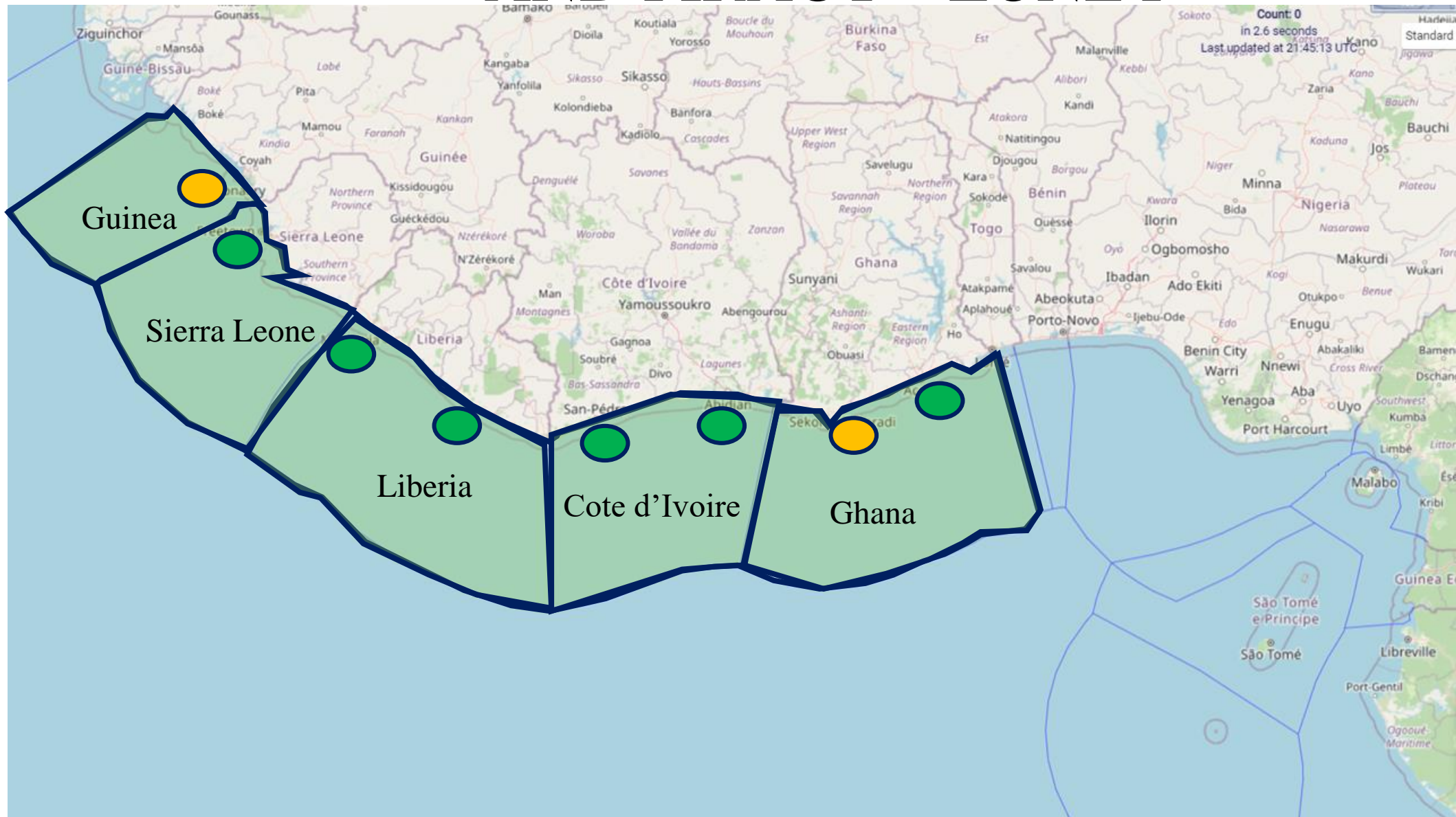

MARITIME RISK ANALYSIS ARMED ROBBERY AND PIRACY – ZONE F



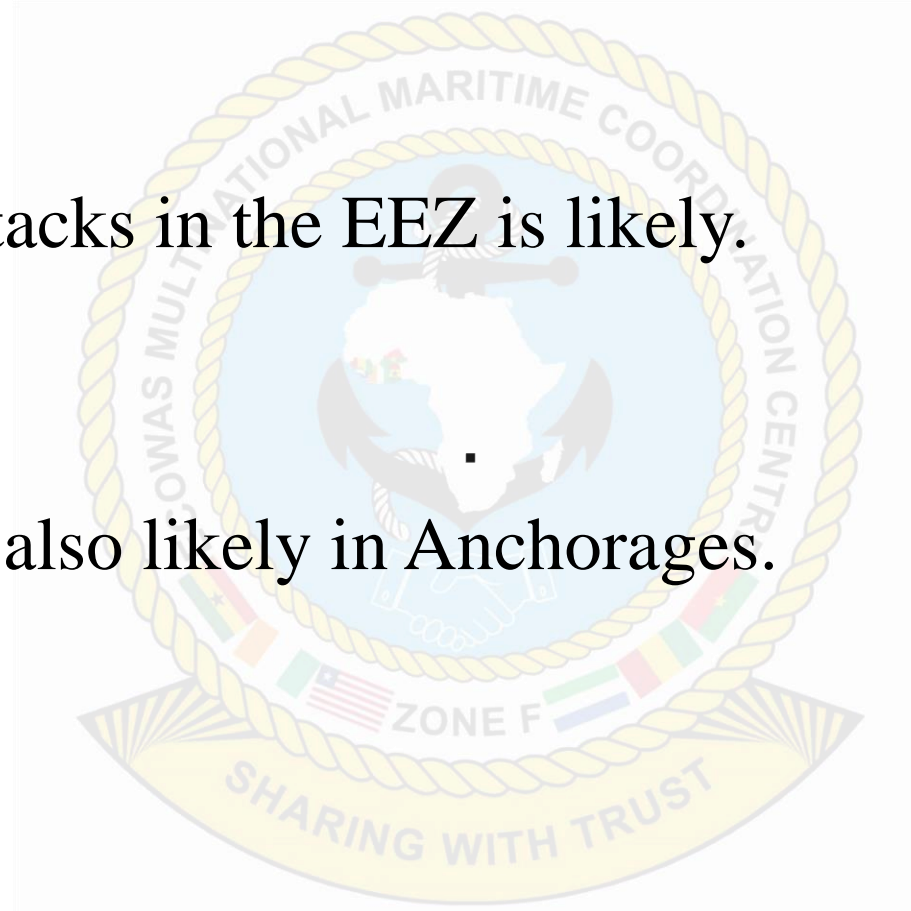

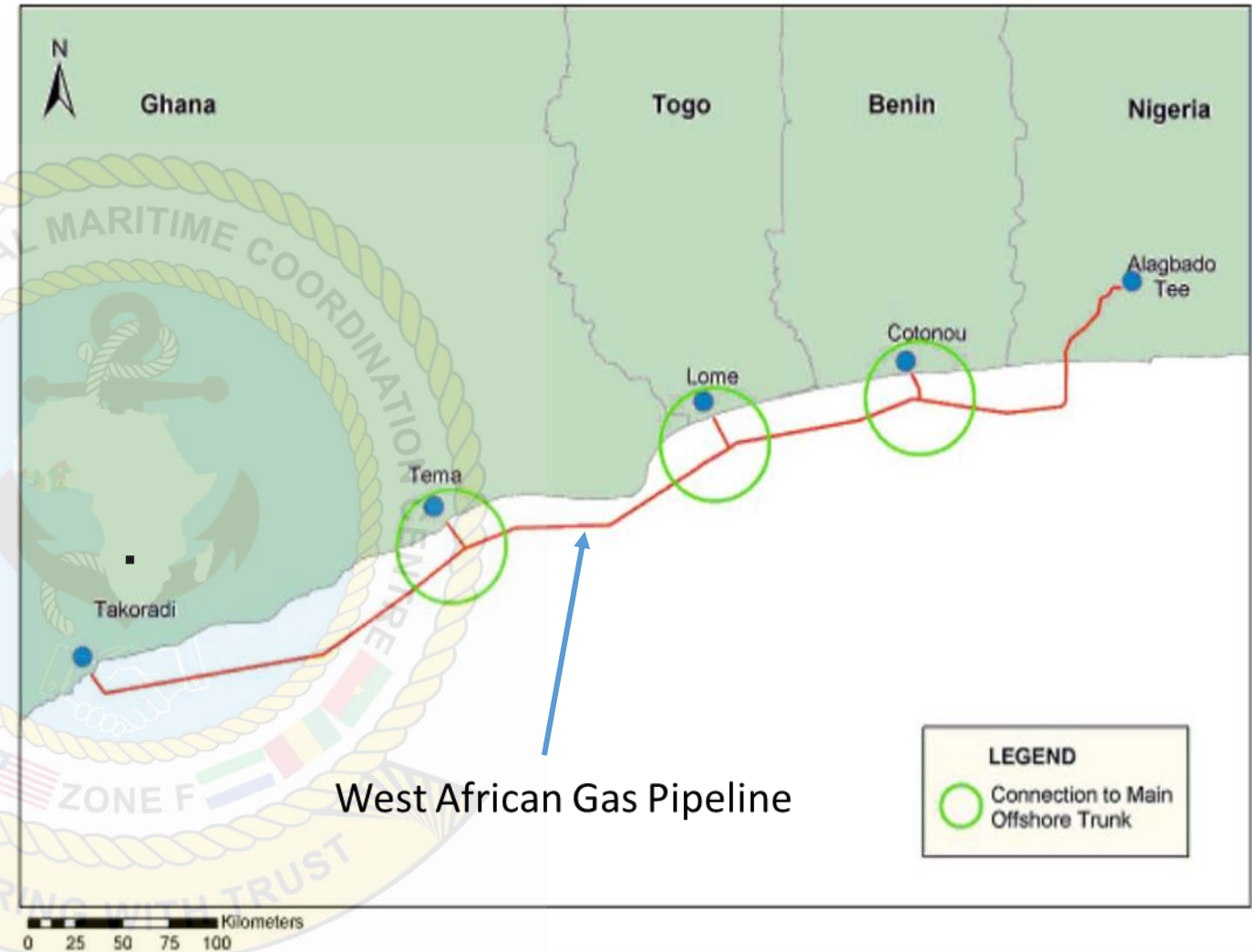

Oil Fields

- All vessels transiting close to the oilfields are to observe the promulgated maritime safety and security zones around the oil fields.

West African Gas Pipeline

- The West African Gas pipeline extends from Takoradi in Ghana to Nigeria. The pipeline since its installation, has experienced periodic breakages due to fishing and anchoring activities on the pipeline.
- The position of the pipeline is shown on maritime charts.
- All vessels transiting the coastal areas between Ghana and Nigeria are to avoid anchoring and fishing within the pipeline protective zone.



MARITIME NEWS OF INTEREST

Cost Estimates for Repairs to HMS Prince of Wales Skyrocket

The UK's troubled plagued aircraft carrier the HMS Prince of Wales is the focus of a new controversy after The Times [London] published a report at the end of last week contending the problems were known before the Royal Navy took delivery and that taxpayers will now have to pay for the repairs to the vessel. The carrier remains in a dry dock in Scotland with her return to service being delayed till late spring with the Ministry of Defense having also launched an investigation into the carrier and its issues.

Costing an estimated £3.2 billion (\$4 billion) to build, the carrier which was the most expensive warship ever built for Britain was delivered to the Royal Navy in December 2019. Reports indicate that the vessel has spent more time undergoing repairs since her delivery than in service as the Royal Navy sought to complete her commissioning and preparation for active duty. In August 2022, she was set to begin one of her highest-profile duties since delivery with a tour that was to cross the Atlantic for joint exercises with the U.S. Navy. Shortly after departure from Portsmouth, however, the carrier was forced to anchor and it was later determined that a coupling had failed on her starboard shaft causing significant damage to the shaft and propeller, with superficial damage to the rudder.
