DEFINITION OF TERMS

- **PIRACY**

(A) Any illegal acts of Violence or Detention, or any act of Depredation, committed for private ends by the crew or the passengers of a private ship or a private aircraft, and directed: (i) on the High Seas, against another Ship or Aircraft, or against persons or property on board such ship or aircraft. (ii) against a ship, aircraft, persons or property in a place outside the jurisdiction of any State.

(B) Any act of voluntary participation in the operation of a ship or of an aircraft with knowledge of facts making it a pirate ship or aircraft.

(C) Any act of inciting or of intentionally facilitating an act described in subparagraph (a) or (b).

- **ARMED ROBBERY AT SEA**

Any unlawful act of Violence or Detention, or any act of Depredation or Threat other than an act of Piracy, directed against a Ship or against Persons or Property onboard such Ships, within a States jurisdiction over such offences.

- **HIJACK:** Vessels taken by attacker, no longer under the control of the master.
- **FIRED UPON/ATTACK:** Use of weapon by assailants at vessel or boarding with intent to take control of the vessel.
- **BOARDING:** Unauthorized boarding of a vessel by persons not part of its complement without taken control of the vessel.
- **ROBBERY:** Theft realize in territorial waters with threat or violence to crew.
- **THEFT:** Theft realize in territorial waters with no violence.
- **ILLEGAL UNREPORTED UNREGULATED FISHING.**

Illegal fishing conducted by national or foreign vessels in contravention of laws and regulations. Fishing conducted by vessels flying the flag of States that are parties to a regional fisheries management organization but operate in contravention of the conservation and management measures. Fishing in violation of national laws or international obligations. Fishing activities which have not been reported, or have been misreported. Fishing in the area of application of a regional fisheries management organization that are conducted by vessels without nationality. Fishing in areas or for fish stocks in relation to which there are no applicable conservation or management measures.

- **MARITIME MIGRATION.**

STOWAWAY: A person who hides on a ship, aircraft, or other vehicle 2. Someone who hides on a ship or aircraft to travel without having to pay.

- **ILLICIT TRADE.**

ILLEGAL BUNKERING: Bunkering is a term used to describe the process of filling a ship with oil (or coal). Illegal oil bunkering is a euphemism for theft.

- **OTHER MARITIME INCIDENTS.**

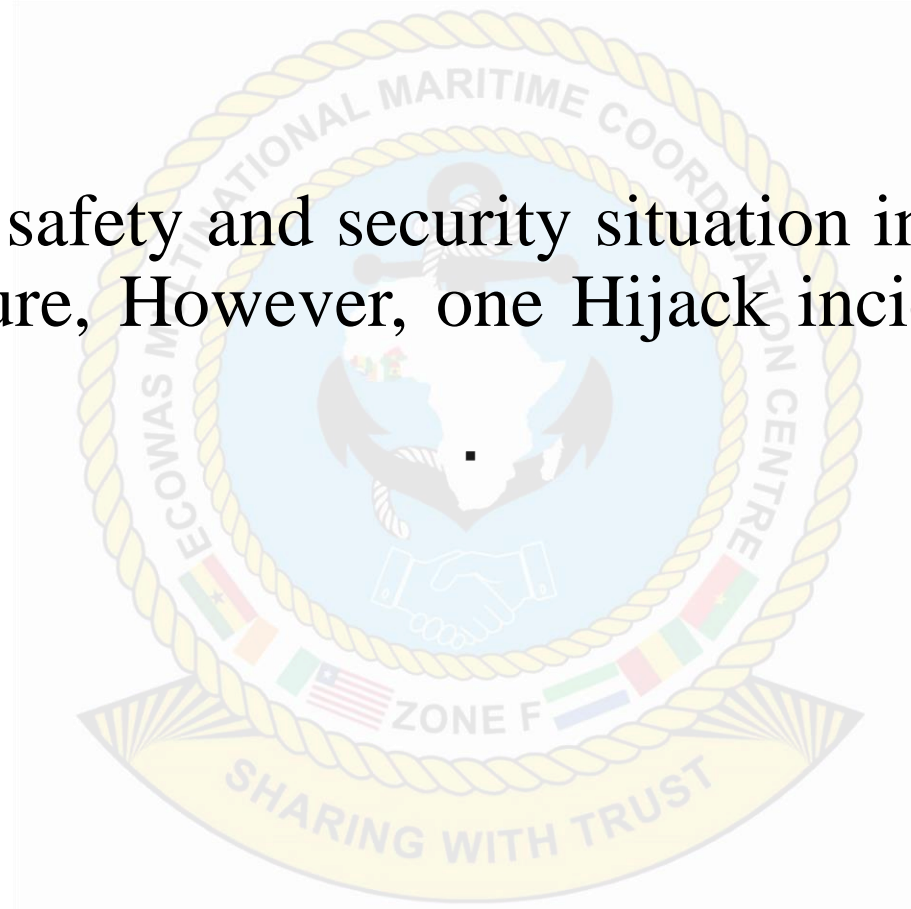
SUSPICIOUS APPROACH: All other unexplained activity in close proximity of an unknown vessel.

SIGHTING AND IRREGULAR ACTIVITY: All suspicious information with no proof of intent to board the vessel.

DETAILS OF INCIDENT

HIJACKING– OFF COTE D’IVOIRE

Information received indicates that, The Singapore flag chemical tanker SUCCESS 9 was reported as having been attacked by unknown perpetrators about 307 NM south of Abidjan in the Gulf of Guinea at 1400 UTC on 10 April 2023 at position 00°07'N 004°34'W.

MMCC Zone F shared the information received to all the relevant stakeholders. Coordination was done within the member states and request for authorisation for search was sent to some member states. On 10 April at 1500 UTC The Ivorian Navy ship, CA FADIKA was sailed to the general area to provide assistance to the vessel. CA FADIKA arrived at the area while the French falcon 50 was also task to fly over the area. Both the navy ship and the French falcon 50 continue in search for the vessel until now while the Spanish navy ship AUDAZ has join the search for MT SUCCESS 9.

MMCC Zone F will provide update accordingly.

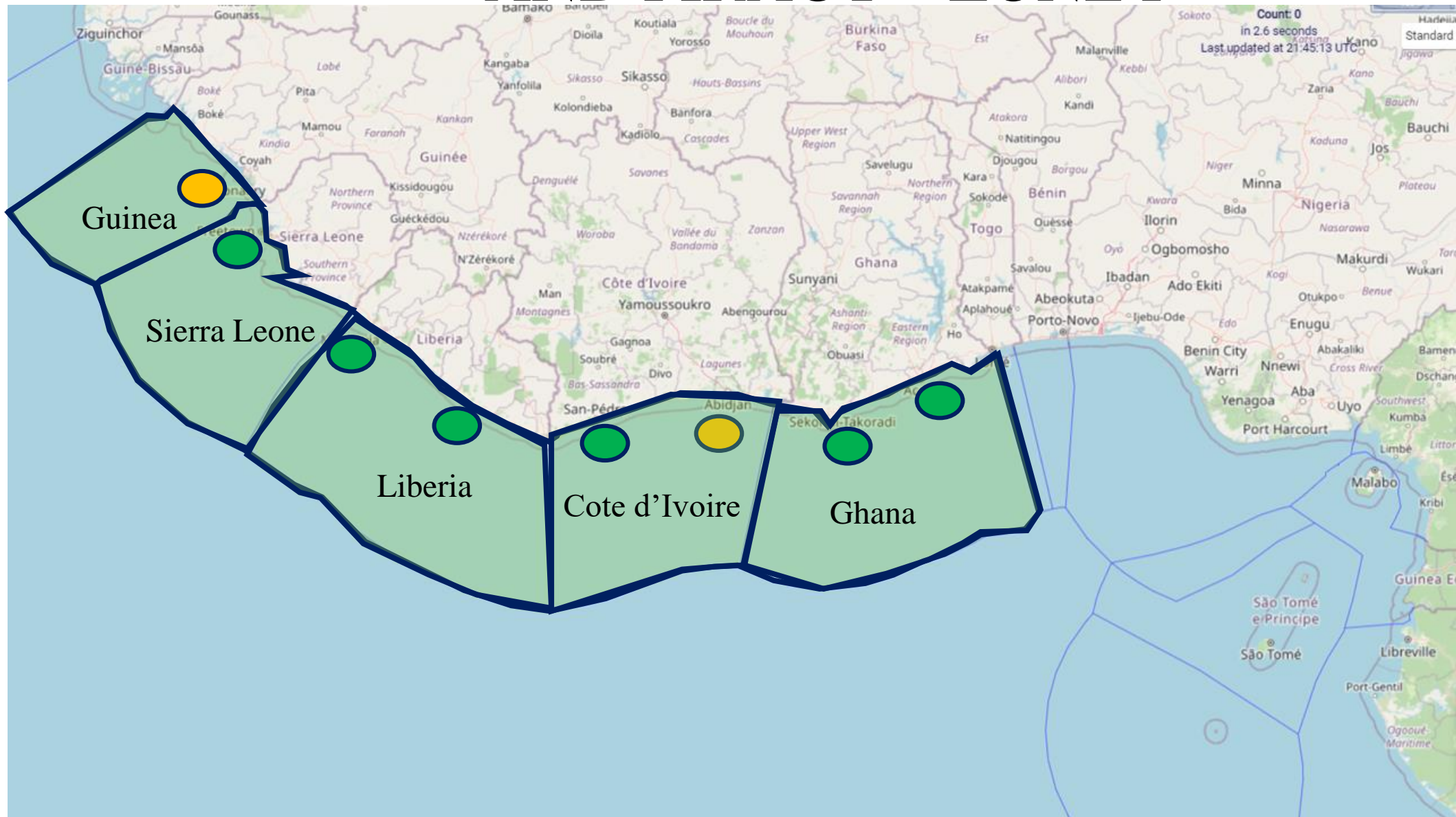

MARITIME RISK ANALYSIS ARMED ROBBERY AND PIRACY – ZONE F



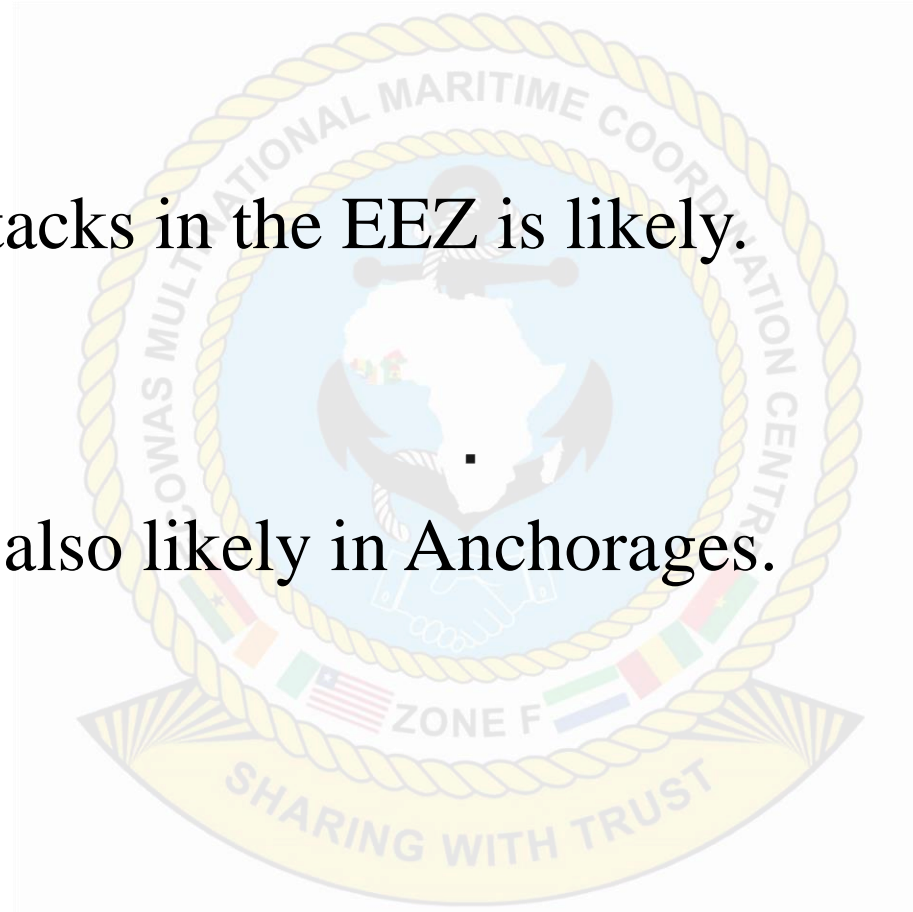

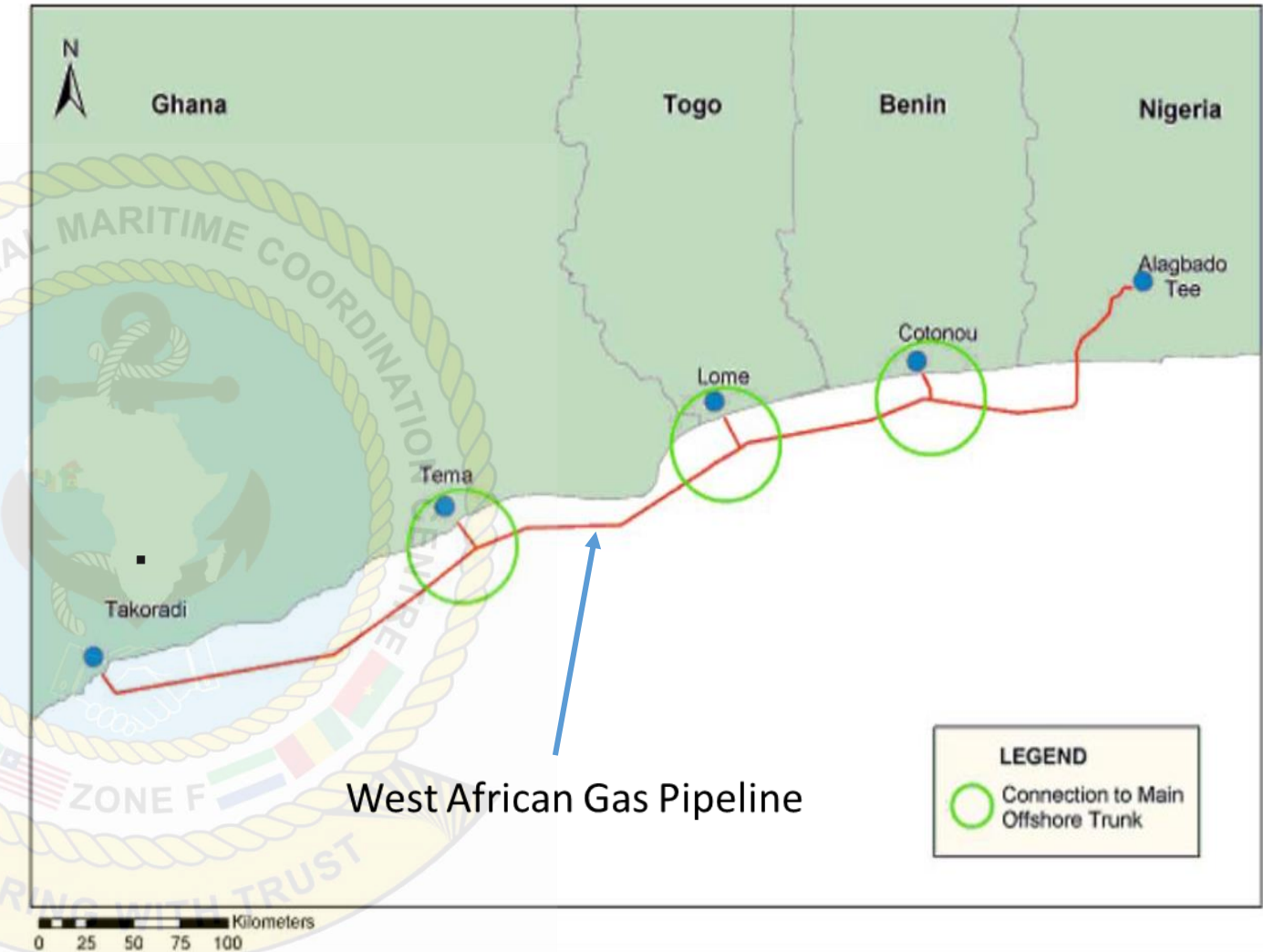

Oil Fields

- All vessels transiting close to the oilfields are to observe the promulgated maritime safety and security zones around the oil fields.

West African Gas Pipeline

- The West African Gas pipeline extends from Takoradi in Ghana to Nigeria. The pipeline since its installation, has experienced periodic breakages due to fishing and anchoring activities on the pipeline.
- The position of the pipeline is shown on maritime charts.
- All vessels transiting the coastal areas between Ghana and Nigeria are to avoid anchoring and fishing within the pipeline protective zone.



MARITIME NEWS OF INTEREST

Nigerian Navy Intercepts Hijacked Vessel, Rescues Crew Members, Launches Manhunt for Fleeing Pirates

The Nigerian Navy said it has intercepted and rescued Motor Tanker (MT) Monjasa Reformer off the Island of Principe. This is even as it confirms that it is intensifying a manhunt for the pirates that attacked the ship recently. The ill-fated ship is currently anchored in a Lagos port, for safety. MT Monjasa Reformer with IMO number 9255878 was attacked and boarded by pirates on March 25, 2023, at about 2239 UTC in position 05:29.35 South – 009:34.00 East, around 144 nautical miles (nm) West-South-West of Pointe-Noire, Democratic Republic of Congo.

A statement by the Director of Naval Information, Commodore Adedotun Ayo-Vaughan, said at the time of the attack, the vessel was also about 95 nautical miles off the Etame Terminal.
