DEFINITION OF TERMS

- **PIRACY**

(A) Any illegal acts of Violence or Detention, or any act of Depredation, committed for private ends by the crew or the passengers of a private ship or a private aircraft, and directed: (i) on the High Seas, against another Ship or Aircraft, or against persons or property on board such ship or aircraft. (ii) against a ship, aircraft, persons or property in a place outside the jurisdiction of any State.

(B) Any act of voluntary participation in the operation of a ship or of an aircraft with knowledge of facts making it a pirate ship or aircraft.

(C) Any act of inciting or of intentionally facilitating an act described in subparagraph (a) or (b).

- **ARMED ROBBERY AT SEA**

Any unlawful act of Violence or Detention, or any act of Depredation or Threat other than an act of Piracy, directed against a Ship or against Persons or Property onboard such Ships, within a States jurisdiction over such offences.

- **HIJACK:** Vessels taken by attacker, no longer under the control of the master.
- **FIRED UPON/ATTACK:** Use of weapon by assailants at vessel or boarding with intent to take control of the vessel.
- **BOARDING:** Unauthorized boarding of a vessel by persons not part of its complement without taken control of the vessel.
- **ROBBERY:** Theft realize in territorial waters with threat or violence to crew.
- **THEFT:** Theft realize in territorial waters with no violence.
- **ILLEGAL UNREPORTED UNREGULATED FISHING.**

Illegal fishing conducted by national or foreign vessels in contravention of laws and regulations. Fishing conducted by vessels flying the flag of States that are parties to a regional fisheries management organization but operate in contravention of the conservation and management measures. Fishing in violation of national laws or international obligations. Fishing activities which have not been reported, or have been misreported. Fishing in the area of application of a regional fisheries management organization that are conducted by vessels without nationality. Fishing in areas or for fish stocks in relation to which there are no applicable conservation or management measures.

- **MARITIME MIGRATION.**

STOWAWAY: A person who hides on a ship, aircraft, or other vehicle 2. Someone who hides on a ship or aircraft to travel without having to pay.

- **ILLICIT TRADE.**

ILLEGAL BUNKERING: Bunkering is a term used to describe the process of filling a ship with oil (or coal). Illegal oil bunkering is a euphemism for theft.

- **OTHER MARITIME INCIDENTS.**

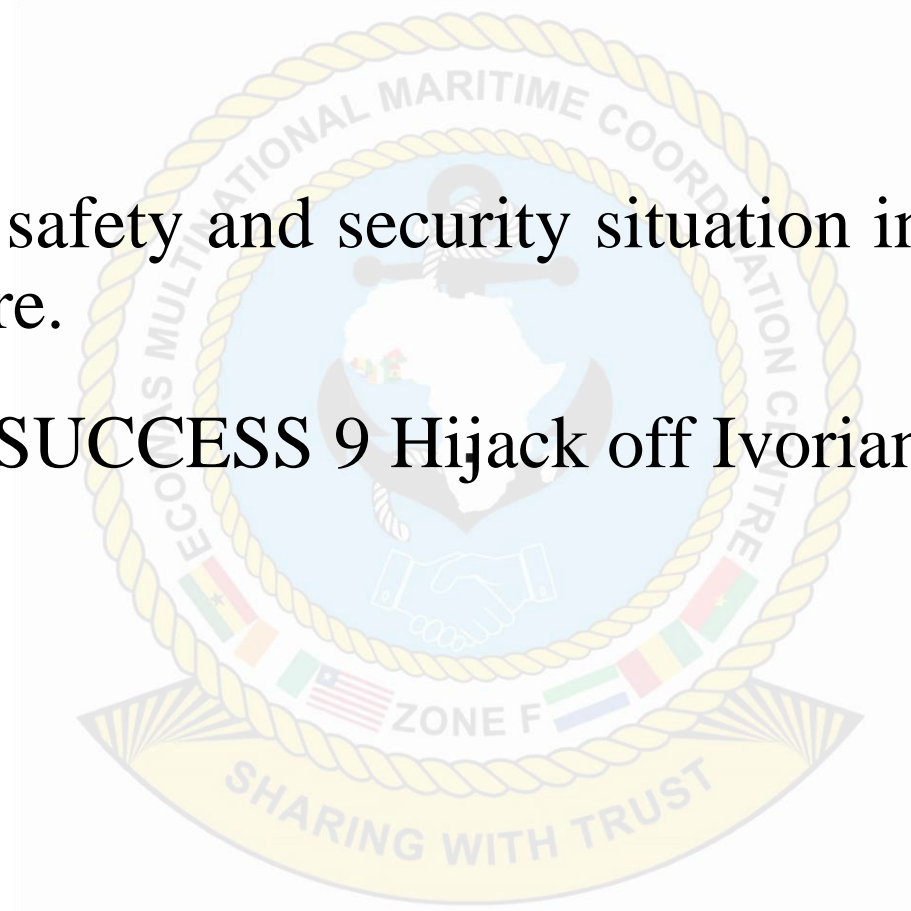
SUSPICIOUS APPROACH: All other unexplained activity in close proximity of an unknown vessel.

SIGHTING AND IRREGULAR ACTIVITY: All suspicious information with no proof of intent to board the vessel.

DETAILS OF INCIDENT

UPDATED REPORT OF HIJACKED VESSEL SUCCESS 9 – OFF COTE D’IVOIRE

Recall on The Singapore flag chemical tanker SUCCESS 9 which was attacked by unknown perpetrators about 307 NM south of Abidjan in the Gulf of Guinea at 1400 UTC on 10 April 2023 at position 00°07'N 004°34'W.

On April 15, 2023 Information received from Maritime and Port Authority (MPA) Singapore indicated that the MT SUCCESS 9 was sighted by MT MONJASA SPRINTER about 30NM south of Abidjan Port.

The French falcon 50 flew over the said position and confirmed the location of the vessel. MT SUCCESS 9 was escorted by the patrol boats CA FADIKA and CF SEKONGO of the Ivorian Navy with the support of the FALCON 50 to the inner harbour of the port of Abidjan today at 1430Z.

Investigations revealed that 5300 MT of MGO and personal items of the crew were stolen by the pirates. The crew are safe but the vessel's navigational equipment were damaged.

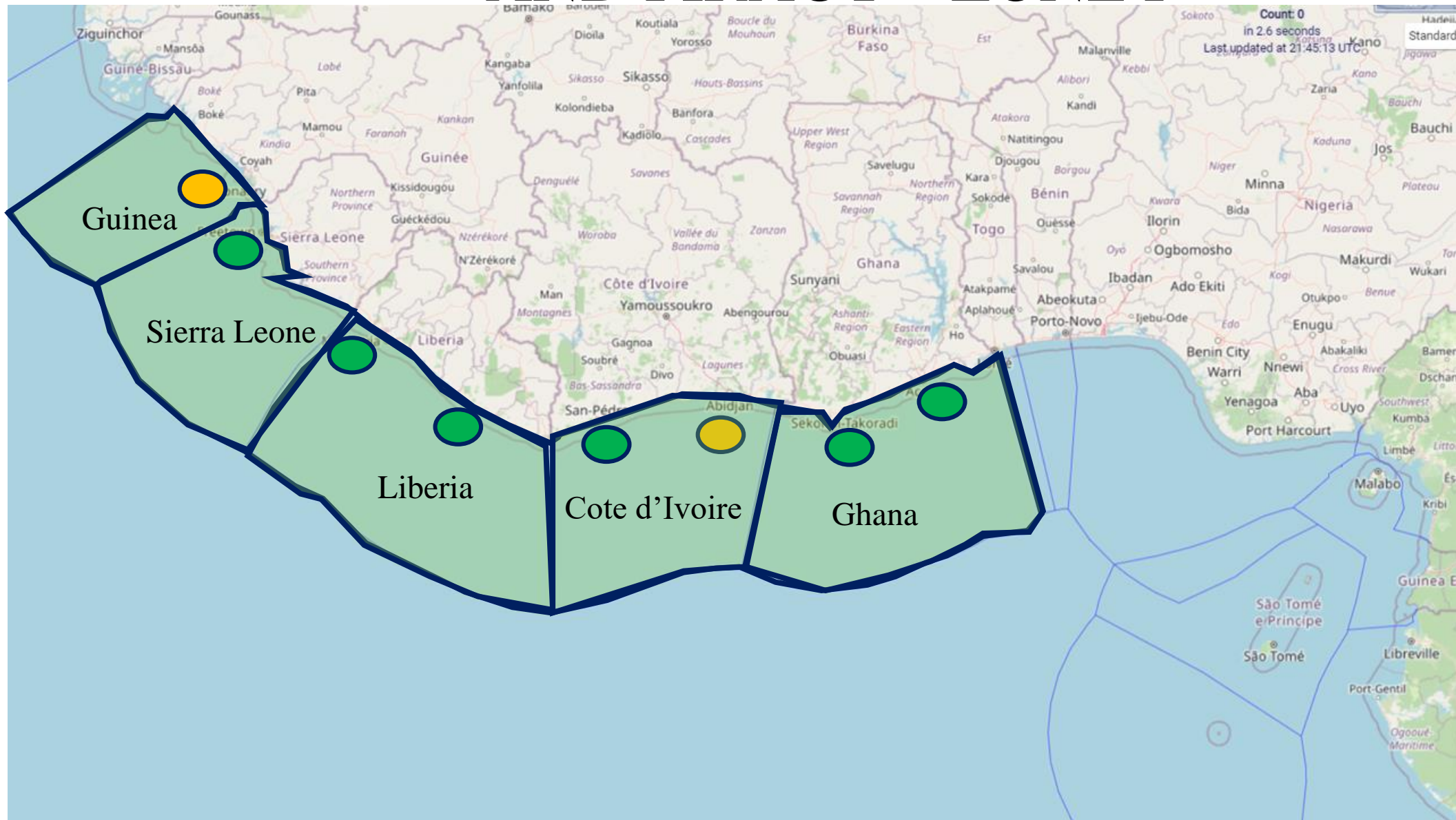

MARITIME RISK ANALYSIS ARMED ROBBERY AND PIRACY – ZONE F



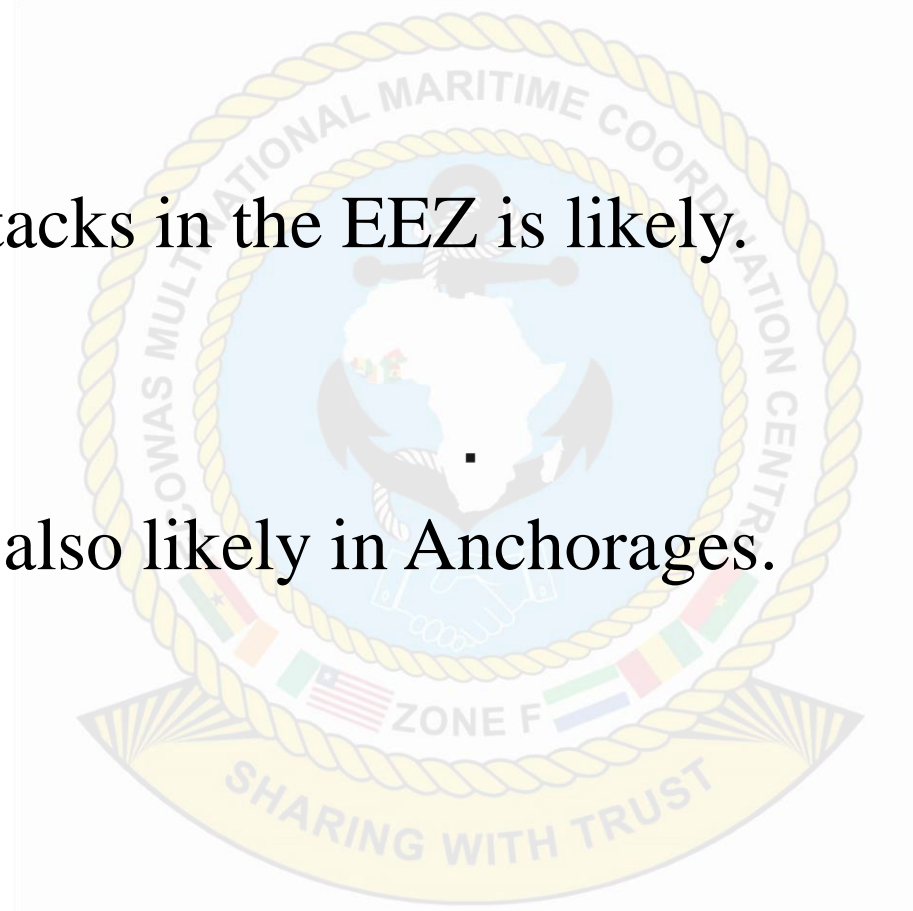

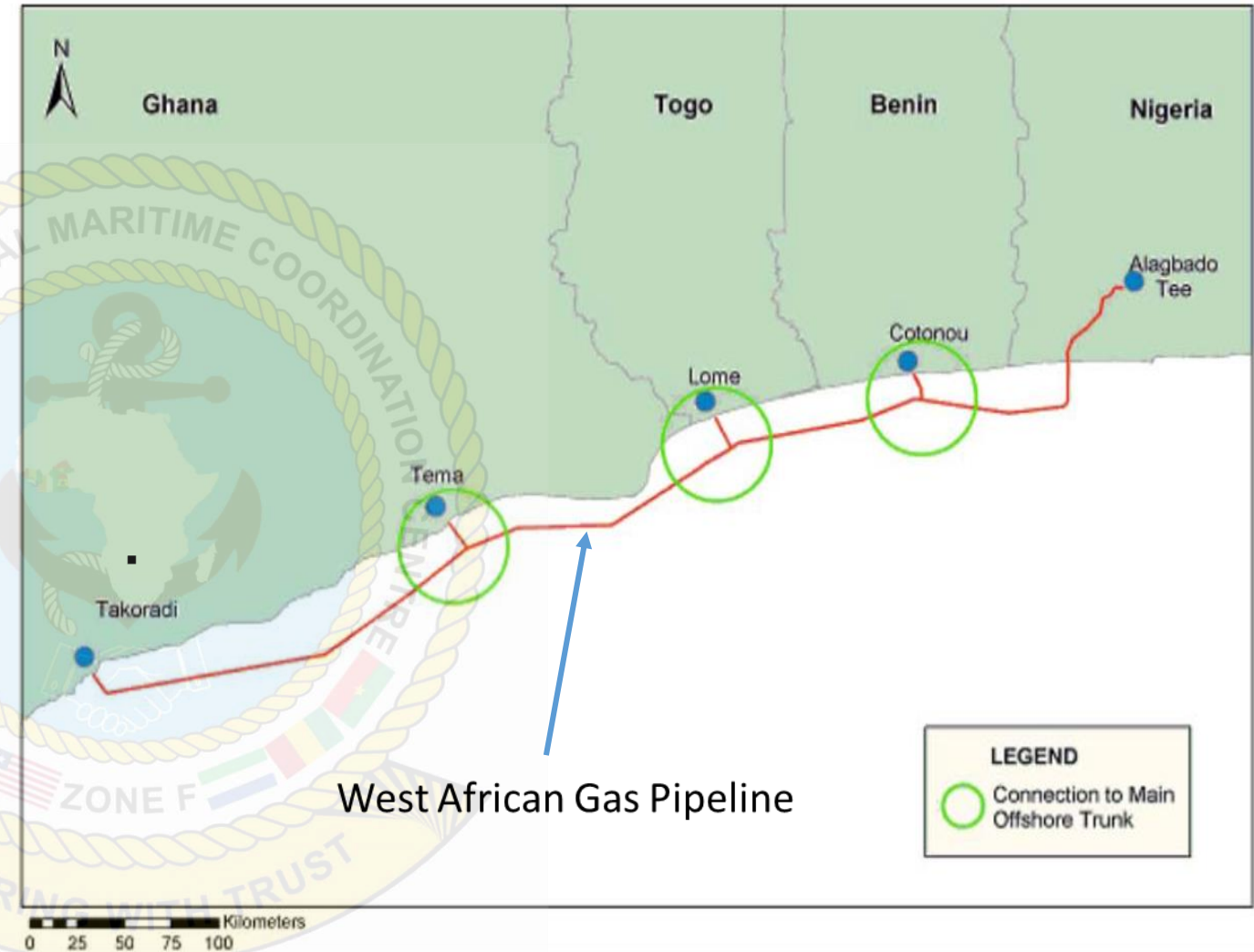

Oil Fields

- All vessels transiting close to the oilfields are to observe the promulgated maritime safety and security zones around the oil fields.

West African Gas Pipeline

- The West African Gas pipeline extends from Takoradi in Ghana to Nigeria. The pipeline since its installation, has experienced periodic breakages due to fishing and anchoring activities on the pipeline.
- The position of the pipeline is shown on maritime charts.
- All vessels transiting the coastal areas between Ghana and Nigeria are to avoid anchoring and fishing within the pipeline protective zone.

CNS REJECTS IMB's PIRACY, ARMED ROBBERY IN GHANA CLAIMS

The Chief of the Naval Staff (CNS) of the Ghana Armed Forces (GAF) – Rear Admiral (R/Adm) Issah Adam Yakubu, has refuted claims made by a Malaysian-based international maritime setup, that sought to portray Ghana as one of the countries that recorded the highest number of piracy incidents, in 2022.

Speaking in an address at an event where the Danish Government donated two vehicles to Ghana Navy's (GN) Special Boat Squadron, at the Naval Headquarters, Burma Camp, Accra. Admiral Yakubu described the latest data on piracy released by the International Maritime Bureau (IMB) Piracy Reporting Centre, as utterly misleading and disingenuous.
